Strategy

Portfolio 1 invests the major part of its assets in fixed income markets and targets investors who seek lower but constant returns at lower risk.

In order to achieve the investment target, Portfolio 1 invests in ETFs (exchange-traded funds) and investment funds of the following asset classes: Money market, bonds, equities and alternative investments (hedge funds, managed futures, commodities). The selection of the individual ETFs and investment funds is based on a quantitative, systematic approach that mainly analyses the historical performance and volatility of the individual instruments. The composition of the portfolio will be adjusted regularly (generally monthly) to keep the risk/return profile inline with the target level.

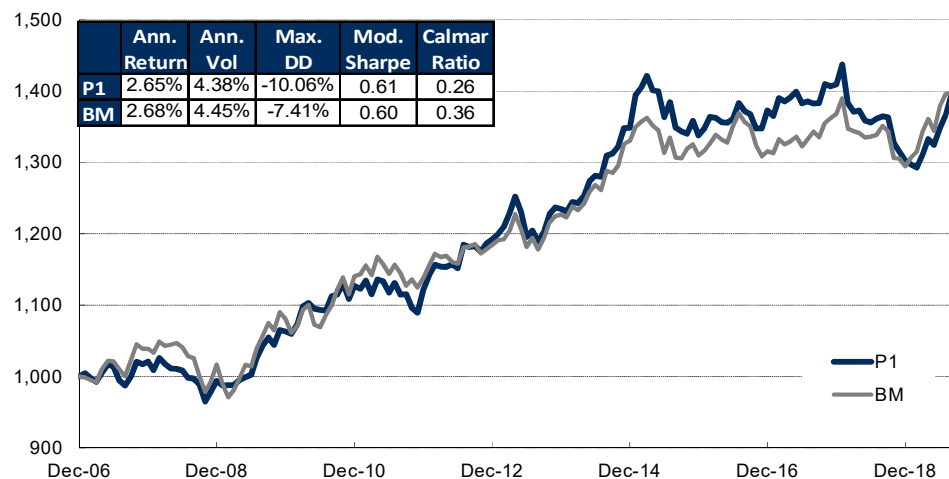
Allocation targets:

Bonds: 0% - 60%
Equities: 0% - 20%
Alt. Inv.: 0% - 20%

These targets serve as reference points and may be subject to change due to market fluctuations.

Benchmark (BM): 60% Bonds (Bloomberg Barclays Global Aggregate Bond Total Return Index), 20% Stocks (MSCI World Net Total Return Index), 20% Managed Futures (SG Trend Index)

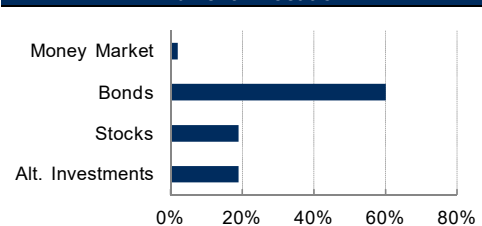

The Synthetic Risk Reward Indicator is used to classify investment funds into different risk categories from 1 to 7. The calculation is based on the historical volatility (annualized standard deviation) of the monthly returns over the last five years.

Portfolio 1 is classified as risk category 3 since its volatility over the last five years ranges between 2%-5%.
